# **Address Database Import Format**

The MIL-Comply Address Database may be populated with data from other systems by importing Address definitions in Comma-Separated Values (CSV) format. The imported addresses are considered to be general purpose, rather than associated with a specific contract or shipment. Perform import in AdminTools: Tools > Database Tools > Address Data > Import > CSV/MCA File.

The import is handled as a Mil-Comply Archive (MCA) file, such as that exported from MIL-Comply, but can be a file generated by some other system. The file should have either an MCA or CSV extension, and be comma separated (versus tab). The import file may include other records for other tables, but they will be ignored. The first two columns of the file identify the purpose of the record, that being a Address record with version 1 formating.

## **CSV Format for Address Import**

MIL-Comply currently supports only the CSV file format described below. The first line of the file may optionally include the column headings, but if present, must match those defined below.

Note that CSV files require that elements containing a comma must be enclosed in quotes. For example, see first two addresses (1HLD9) below. Those two addresses also demonstrate use of adrUsage to store two different addresses for the same entity.
